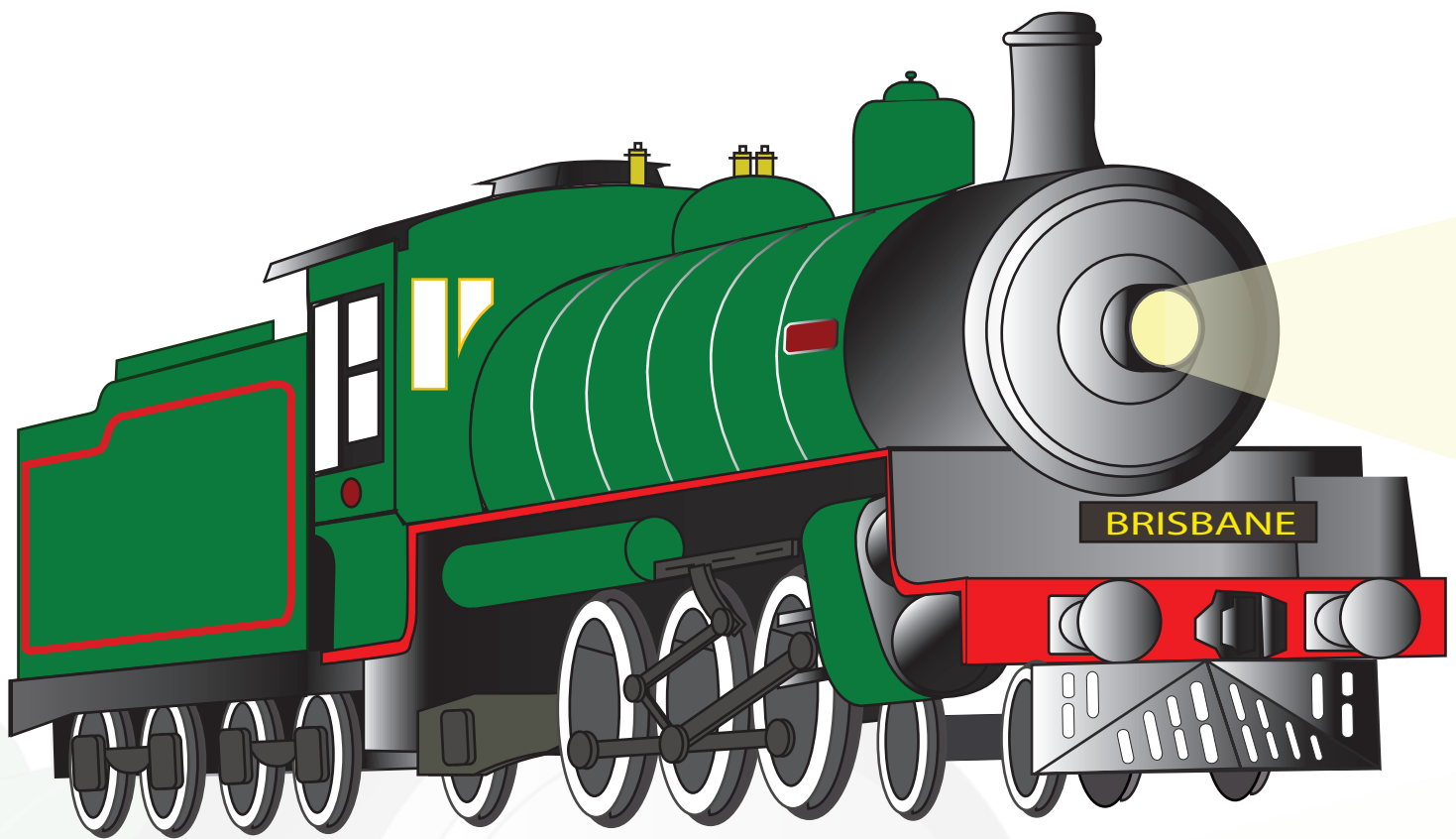

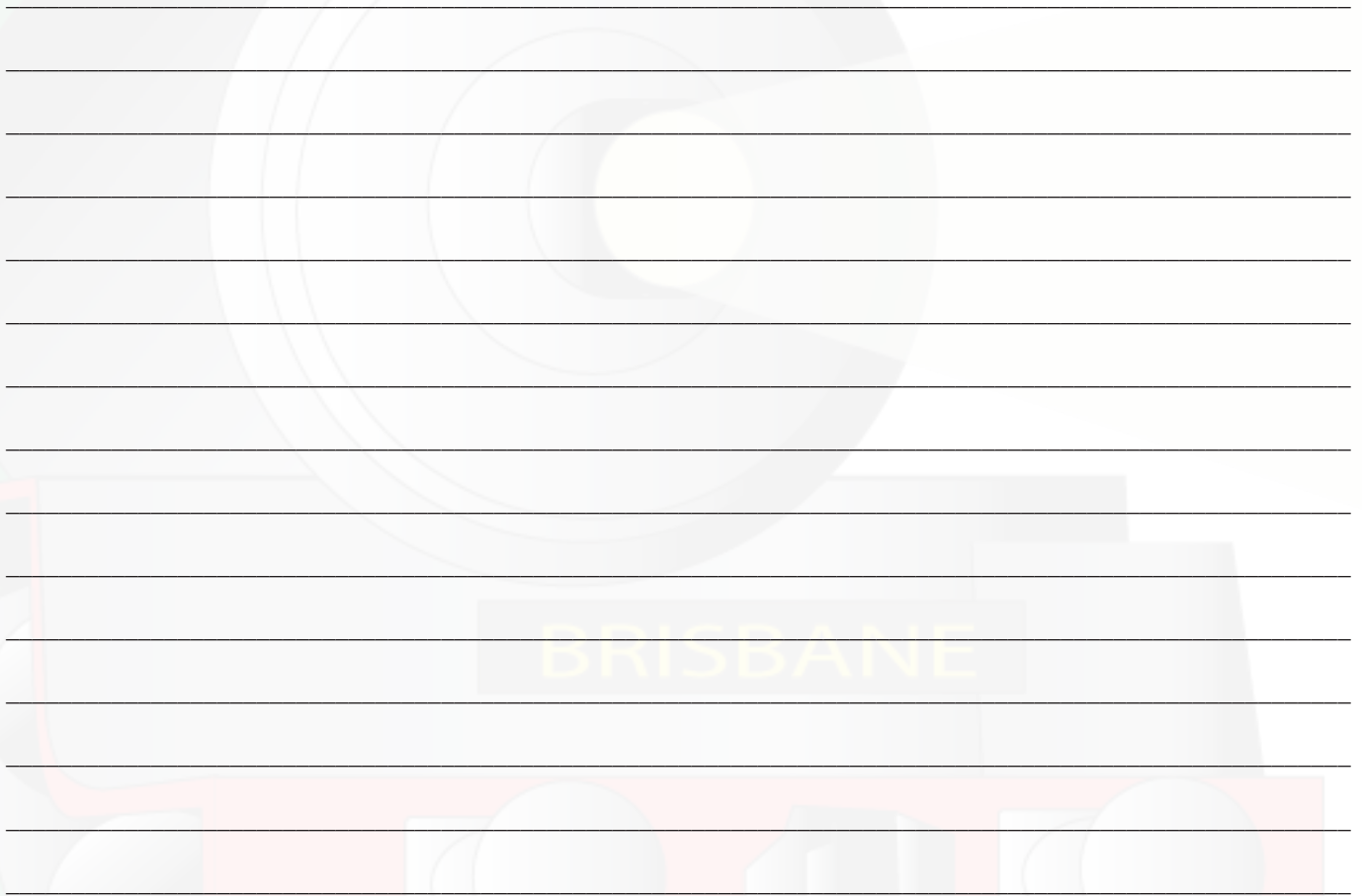

CHANGES FOR 2015

AMRA (QLD) is inviting applications for the Brisbane Model Train Show 2015 which will be held on May the 9th and May the 10th in 2015. Applications for layouts will be closing on the 31st of December 2015.

With the Brisbane Model Train Show 2015 moving to 'The Marquee' in 2015, we return to a familiar location, but in a new building. For 2015 we have got some new requirements for all traders/exhibitors and layouts which are listed below.

1. During all setup times (Friday all day and Sunday evening during pack down) ALL people on site are required to have the following, no exceptions.

High Visibility Vest or High Visability Clothing

Closed in Shoes

No Unsupervised Children under 16 years.

You will be refused access to the site if you do not comply with the above requirements as this is regulated by the "Brisbane Showgrounds" and will be enforced for safety reasons. This is due to the heavy traffic of vehicles in and around The Marquee during these times. The Marquee has a subtle gradient on the north western side of the building. Layouts should be prepared to level their store and provide their own materials to do so. If this is impossible, please make us aware into the more information section on page 2.

2. When advertising for the Brisbane Model Train Show in 2015, we are located in "The Marquee" at the "Brisbane Showgrounds". They are no longer called the RNA and thus have requested to be called by their correct business title. All of our advertising will reflect this, and use of the "RNA" as the title not recommended.

3. AMRA QLD and/or Brisbane Showgrounds will not be providing lunch for exhibitors or traders. Similar to previous years, we will have a Tea & Coffee Room setup for all exhibitors and layout operators to use. We have no restriction on patrons bringing their own food and drink to the venue. No alcohol is permitted on site. It is our request that everyone using this room, endeavour to keep it clean and tidy.

4. Parking is available on site for \$12 a day. To cover such costs, we have reduced the cost per square metre to cover parking costs over the weekend. Trailers will be able to be stored on site, in a dedicated trailer storage area located inside The Marquee, giving access during the day for layouts, exhibitors and traders. If you choose to not leave your trailer in the storage area the total cost for both Car and Trailer is \$15 per day.

5. All Layouts/Exhibitors and Traders are required to have their own Public Liability Insurance. We will require a 'Notice of Currency' with this documentation for your application to be accepted.

6. Due to the sheer amount of applications recieved in the past, we can not gurantee all applications will be accepted. This is up to the discession of the Show Committee. Any special requests for a specific location should be made in the comments and other information section located on page 2. If we fill up on space, we will create a reserve list of layouts/traders who will be contacted if/when space becomes available.

7. Traders and Exhibitors are encouraged to provide their own lighting sources. This will help give your store the correct lighting as the venue may not have the lighting to best show off your product.

TERMS AND CONDITIONS FOR TRADERS



The following Terms and Conditions are applied to all Traders and Stores attending the event.

1. The Brisbane Model Train Show reserves the right to refuse traders from applying for the event.
2. AMRA QLD will provide the power drops, however all electrical items MUST have a current and valid "electrical safety tag" on all items they wish to plug into any power source over the weekend.
3. Closed in Footwear is required at all times (including setup).
4. High Visibility Vests/Clothing are required during setup times.
5. There is NO Smoking inside or within 4m of the doors of The Marquee. A designated spot has been assigned.
6. Alcohol and Illicit Drugs of any kind found on any person, will have them removed from the site.
7. All Traders must have their own Public Liability Insurance. Notice of Currency is required with application.
8. Stores and Surrounding areas are to be kept clean and hazard free over the course of the entire event.
9. Any Trader wishing to sell second hand items, will require a current Queensland Second Hand Dealers Licence. We require this to be on copied and sent to us with this application if you wish to sell second hand items.
10. AMRA QLD will not be providing change or eftpos facilities at our ticket booth or office.
11. Traders may use Audio/Visual Equipment, but they must keep the volume at a reasonable level. BMTS Staff may ask for volume to be reduced if complaints are recieved.
12. Traders and Exhibitors must wear their exhibitors wristband at all times. Replacements can be purchased.
13. AMRA QLD does not provide any lunch for Layouts/Traders/Exhibitors, however the tea room is available.
14. AMRA QLD will be taking photos and video over the weekend. We reserve the right to use them for future promotional usage for The Brisbane Model Train Show in future years.
15. Nothing may be affixed to the Marquee walls. They are to be kept clear and un-damaged.
16. Times for setup and bump out are as follows. Vehicles will only be allowed inside during certain times ONLY.
Friday 8th May 2015 : 10am till 9pm (vehicles after Noon ONLY)
Sunday 10th May 2015 : 4pm till 9pm (vehicles after 5pm ONLY)
17. AMRA QLD or BMTS2015 does not provide any transportation or accomodation for exhibitors.
